ReLegat, Hong Kong let dated 2/15/68 captioned "DOMINIC FURCI; SANTO TRAFFICANTE."

For information of the Bureau, referenced Legat, Hong Kong letter set forth information indicating that FRANK CARMEN FURCI normally maintained his residence in Saigon and therefore Legat, Manila, was requested to interview FURCI.

Investigation by the Tampa Division, however, indicates that FRANK CARMEN FURCI currently maintains a residence at the Ambassador Hotel, Hong Kong, and is currently operating a restaurant known as San Francisco Steak House.

In view of this, Bureau is requested to have Legat, Hong Kong interview FURCI relative to the visit of SANTO TRAFFICANTE, JR., which occurred in January of 1968 and the details of which are available to Legat, Hong Kong.
