He reportedly departed Costa Rica on 8/31/75 en route to Santiagó, Chile; Lima, Peru; and Buenos Aires, Argentina. He returned to Costa Rica on the morning of 9/10/75 from Panama aboard LACSA Flight 610. Source indicated that TRAFFICANTE is met at the San Jose Airport on each occasion of his arrival into Costa Rica by EVARISTO GARCIA VIDAL. Source indicated that GARCIA VIDAL reportedly has a close association with Colonel ROSENDO MERRERA, Chief of the Department of Criminal Investigations, Costa Rican National Police, and with MARIO-CHARPENTIER, Costa Rican Minister of Public Security. Subject reportedly owns a house in the Barrio Las Americas in San Jose. CHATE Sergeant JORGE LATINEZ (protect), Panama National Guard, Panama City, Panama, on 9/11/75, advised that subject was detained 8/2/75 at the Tocumen International Airport at Panama City. and PASSINI were released the same date... Subject's wife reportedly called someone in the USA from Panama, a congressman or senator who in turn called the U.S. Embassy in Panama. The Embassy thereafter called the Panamanian Department of National Investigations to inform them that there were no warrants or holds against TRAFFICANTE. Subject was released 8/4/75 and departed Panama en route Costa Rica the same date.

Inquiry through the U.S. Embassy at Panama City, Panama, on 9/11 and 9/12/75 failed to indicate any record of subject sovisit or supposed call from the USA concerning the subject.
