RE MEXICO CITY CABLE JUNE ONE FOUR LAST. (u)

[MEX-FIVE SIX] RELIABLE, ADVISED JUNE TWO ZERO INSTANT THAT HE HAD CONSULTED WITH MEXICAN PRESIDENT GUSTAVO DIAZ ORDAZ WITH FOLLOWING RESULTS: (u)

THREATENING CABLE WAS RECEIVED BY PRESIDENCY IN MEXICO BUT PRESIDENT DIAZ ORDAZ STATED THAT SINCE IT HAD NOT BEEN DEFINITELY DECIDED THAT A TRIAL WOULD TAKE PLACE AT THIS TIME, HE FELT THERE WAS NO URGENCY AND WISHED TO CONFER WITH MEXICAN ATTORNEY GENERAL TO DETERMINE IF THERE WOULD BE INTERNATIONAL COMPLICATIONS IN VIEW OF THE CABLE BEING ADDRESSED TO PRESIDENT DIAZ ORDAZ PERSONALLY. PRESIDENT DIAZ ORDAZ SAID, HOWEVER, THAT WHEN IT IS DETERMINED THAT A TRIAL WILL TAKE PLACE, HE WISHED TO COOPERATE IN ANY WAY POSSIBLE AND WAS CERTAIN THAT AN APPROPRIATE WITNESS COULD BE MADE AVAILABLE, TOGETHER WITH THE THREATENING CABLE THAT WAS RECEIVED, TO THE RECEIPT OF THE CABLEGRAM (u)
