Pursuant to instructions in reBucab the Paris Office on June 13, 1963 furnished available background data and subject's proposed travel plans to the Police Judiciaire (Criminal Police), Surete Nationale (PJSN), and the Renseignements Generaux (general investigative section), Surete Nationale (RGSN), with the request that in the event of subject's arrival in Paris that appropriate steps be taken in order that the Bureau may be fully apprised of subject's activities here (c)

On June 21, 1963 and July 5, 1963, JEAN CAHEN, Chief, Research Section, RGSN, advised that his service was maintaining stops at the Paris airport and in the event of subject's arrival the Paris Office will be promptly advised (c)

In view of subject's plans to visit Paris in the future this case is being maintained in a pending status and information obtained will be promptly furnished the Bureau.
