ON JULY 29, 1963, PCI TELEPHONICALLY CONTACTED THE NYO FROM CALGORY, CANADA. HE SAID VICTOR COLLING (FORMER PCI NYO) IS NOW IN CALGORY AND TOLD HIM OF THE FIGHT ON NIGHT OF JULY 27, 1963 AT LAKE TAHOE.
