WEEKLY SUMMARY

MM 675-C on 5/2/62, advised he received info that HAROLD SOLOMON has not been making any bail bonds for past 3 weeks; that SOLOMON's insurance company refused to insure his bail bonds any longer; that Miami and Miami Beach authorities will no longer accept any of SOLOMON's bail bonds, because SOLOMON allegedly had \$24,000.00 worth of estreatures in Miami and \$5,000.00 to \$6,000.00 estreatures in Miami Beach. It had previously been alleged that JOSEPH INDELICATO (Miami file 92-404) has some interest and control in the activities of the Harold Solomon Bail Bond business. He further advised that SOLOMON is presently very active and on the payroll of JACK M. TURNER, who is a candidate for the office of Circuit Court Judge.

GEORGE LEBOWITZ, landlord of SOLOMON, advised on 5/7/62, that SOLOMON told him that he had a new insurance company backing him and that he expects to continue in the bail bond business at the same location.

DORR FELDMAN (Miami file 162-19) on 5/8/62, kicked out a porch screen and sat on the 3rd floor ledge of the Jackson Memorial Hospital, Miami, where he is a heart patient, before he was coaxed back inside. The firemen and police rescue squads were called and stationed on the ground beneath him. FELDMAN was admitted to the hospital on 4/30/62.

On 5/4/62, a fisur on PASQUALE ERRA (Miami file 92-648) revealed while he was at the Johnina Hotel, Miami Beach, GEORGE SMURRA, aka George Blair; JOSEPH L. PAGANO, FBI #4674260; MAX EDER (Miami file 92-467), and an individual driving an automobile licensed to DELORES LOPROTO, wife of SALVATORE JOHN LOPROTO, FBI #921798B, were also observed there. LOPROTO is a close associate of JOHN ORMENTO and son-in-law of FRANK LIVORSI. On 5/9/62, PASQUALE ERRA, GEORGE SMURRA, ANTHONY SALERNO (Miami file 92-406) and JOSEPH PAGANO were observed at the Johnina Hotel at the same time.

MM 806-PC on 4/26/62, advised the current pay off percentages are still 70 to 1 for bolita in Dade and Broward Counties. He stated that HYMAN MARTIN (Miami file 92-218) made a trip to Pittsburgh to attend the funeral of his mother and that ABE COHEN handled MARTIN's bolita operation while MARTIN was in Pittsburgh and at the present time is handling a considerable amount of MARTIN's business with bolita operators as MARTIN does not desire to be in contact with any bolita operator.

MM 509-C on 5/1/62, advised that he understood JOSEPH MASSEI (Miami file 92-122) went to Hot Springs, Ark., alone, the latter part of April, 1962, and intends to remain there about a month.

The source also advised that AL MONES (Miami file 92-386) is back in action as a bookmaker; that he currently has RICHARD MARGOLIS and BOB RUSSELL working for MONES. He learned the latter two are extremely busy about 15 mins. before
