MM 509-C also advised on 5/8/62, that JOHN TRONOLONE (Miami File 92-455) and his brother, CARMINE TRONOLONE, have for a opened JERRY's Newstand in North Miami, Fla., as a "front" for a big contemplated bookmaking and shylocking operation. He learned they do not care to handle the bets of any "racket individuals" but will seek the "sucker bettor", specifically, the business man, women, bell hops, etc., as they feel they can make more money on the bets made by those individuals.

This source also advised that he learned WILLIAM GUSTAV BISCHOFF (Miami File 92-89) and JOSEPH INDELICATO (Miami File 92-404) made a financial investment in the Hampshire Towers Apartments, Miami Beach, presently under construction by MARVIN SCHULMAN. He also learned that BISCHOFF and INDELICATO contemplate moving into these apartments when completed.

In addition, this source reported that some sizeable poker games have been going on at Miami Beach No. 1651, Loyal Order to Moose, operated by BEN HUSCK (Miami File 162-80) and WILLIE BITTNER. He related the local bookmaking is handled by BITTNER and HUSICK handles the lay off bets at this club.
