You should maintain close contact with PCI Joseph Hegeman and immediately report any information he receives concerning a possible future meeting of racket attorneys. He should be closely interviewed on all aspects of any future information he furnishes in this regard.

Las Vegas advises that Norman Biltz is a wealthy Reno, Nevada, financier who has no known hoodlum connections. Why Carlos Marcello should send Biltz \$6700 in cash as part payment for attorneys fees is not clear. Clarify this information on your next contact with informant.

NOTE: On May 9, 1962, Miami PCI Joseph Hegeman advised of an alleged meeting of hoodlum attorneys in Reno, Nevada, Saturday, May 12, 1962. Purpose was to map out plans to combat Attorney General's organized crime drive. Informant stopped in Reno on return trip from Los Angeles on May 11 to deliver \$6700 to Norman Biltz and also on the possibility he might get some type of public relations assignment from the racket attorneys. Upon arrival in Reno informant was told by Norman Biltz that meeting had been called off because of a leak in the plans. Since meeting was called off, we have been unable to determine validity of informant's information and Miami is therefore being instructed to pin informant down on future information he supplies.
