CHOATE because there are too many jail cases pending at this time. As of this date, the trial date has not been reset. LAFF is charged with failure to possess a Federal Wagering Tax Stamp. MM 818-C* on 6/6/62, furnished info that JOHN TRONOLONE (Miami file 92-455) has been approached by TOMMY MEYERS, a bookmaker, who is interested in TRONOLONE's bookmaking establishment at Jerry's Newsstand, North Miami, Fla. MM 609-C on 6/4/62, advised that WFTL-FM Radio Station, Ft. Lauderdale, Fla., is broadcasting race results each day and that many bookmakers in the Miami area are using this means to obtain race results. This source related that the program is allegedly sponsored by the Dade Tire Co. of Miami which is allegedly operated by R. C. MC CLENDON and EVERELT W. THOMPSON, who in the past have been bookmakers and bankrollers in the bolita racket. On 6/1/62, SALVATORE M. PARISI, owner of Gerardo's Restaurant, Dade County, Fla., advised that JOE INDELICATO (Miami file 92-404) contacted him approximately 2 months ago, about putting in his cigarette vending machines at Gerardo's Restaurant, but could not identify the company INDELICATO represented. MAXINE MOORE, girlfriend of MILTON SEINFELD, owner of the Admiral Vee Motel, Miami, Fla., confidentially advised on 5/24/62, that INDELICATO contacted SEINFELD regarding the new cigarette machines, which are now in use at this motel. These cigarette vending machines are from the Rex Jay Hollery Co., which company H. H. WOOD, of the Fla. Beverage Dept., believes may be backed by LAZARUS SKOLNECK, who operated Lucky Amusement Co., and who in turn may be backed by INDELICATO.

MM 509-C on 5/29/62, advised that he received info that SAM SCHWARTZ, owner of Wolfies' Restaurant, Lincoln and Alton Rd., Miami Beach, wanted in addition to selling his restaurant to JERRY BROOKS and CHARLES TOURINE (Miami file 92-106) a certain amount of money for the use of the name "Wolfies' Restaurant," after a period of 5 years. He said this and other details have held up the sale of this restaurant. He learned that if this deal fell through there was a possibility the above individuals who desired to purchase the restaurant, may work out another deal where they will acquire the permission, etc., to operate a Wolfies' Restaurant in Miami proper. On 6/5/62, MM 509-C said the deal fell through relative to the purchase of Wolfies' Restaurant at Lincoln and Alton Roads, Miami Beach, but the above contemplated purchasers, plus JOE LIPSKY, owner of Gallaher's Steak House, North Miami, were successful in negotiating toward opening a new Wolfies' Restaurant in the store formerly occupied by the Jefferson Stores across from the 163rd St. Shopping Center, in North Miami Beach. On 6/8/62, MM 807-C advised that he received info relative to the opening of the new Wolfies' Restaurant, and found there was a sign on the premises indicating a Wolfies' Restaurant would open there. He said his inquiry revealed that BERNIE BERMAN was the group's
