WEEKLY AIRTEL SUMMARY

Re Tampa airtel to Bureau, 2/21/63.

The Atlanta office interviewed GASPER G. LAZZARA, son of AUGUSTINE PRIMO LAZZARA, Tampa numbers lottery figure, and LAZZARA stated he resided with Richard VALDES, who is engaged to be married to daughter of subject. LAZZARA stated that he knows that VALDES has used their telephone to call subject's daughter. According to LAZZARA, VALDES, upon learning that LAZZARA was to be interviewed by the FBI, told LAZZARA that while VALDES was in pre-dent school at the University of Florida, his roommate at the University had been interviewed by the Bureau in an effort to obtain information concerning subject. VALDES added that he had no information at all concerning the business affiliations of the subject. It is interesting to note that GASPER G. LAZZARA said that his father was in the produce business in Tampa, Fla.

The NewYORK Office reported that on 2/21/63, NY 382-C-TE advised that he had made a recent business trip to Tampa, Fla. and while there, learned that the TRAFFICANTE Family was reported to be in complete control of organized crime in the Tampa area.

On 2/25/63, Detective CLAYTON BRIGGS and Sgt. JACK de la LLANA, Intelligence Unit, Tampa PD, observed automobiles of the following individuals parked in front of the residence of JOE BEDAMI, recent releasee from the penitentiary and a former partner of FRANK DIECIDUE, one of subject's alleged lieutenants:
