On 3/20/63, TP 80-C* advised that on that date an unknown individual had visited FRANK DIECIDUE at the Dixie Amusement Co., and at 5:00 p.m. had told DIECIDUE that the matter was up to DIECIDUE, but that DIECIDUE had to buy out an individual or sell the business. According to source, the unknown individual told DIECIDUE that he had to come up with the money regardless of how much it would cost. The source stated in answer to this DIECIDUE said he had not questioned the matter, that the unknown individual had told him he was responsible but that if the individual they were speaking about got "that" DIECIDUE was going to contest it.

Information from TP 80-C* undoubtedly refers to subject.

On 3/24/63, TP 31-C advised that he had been invited by NAVARRO, mentioned above, to go to Miami and cover the remaining days of the meet at Gulfstream Race Trace. During the time of the stay in Miami, TP 31-C would stay with NAVARRO and JOHN DEMMI at the Diplomat Hotel and they would be in contact with subject.
