On the same date, JULIAN ACOSTA, National Airlines, and JOE CRENSHAW, Eastern Airlines, Tampa International Airport, both of whom know subject, advised subject had not been seen using any of their flights.

On 5/27/63, Deputy LOWELL STEVE, Sheriff's Office, advised he observed subject, SAM TRAFFICANTE, JIMMY LONGO, and AUGUST PANIELLO at the Columbia Restaurant, At about 9:00 PM the foursome left the Columbia and went directly to 2505 Bristol Avenue, and a check of the residence at midnight disclosed that SAM TRAFFICANTE, JIMMY LONGO and subject were in subject's living room watching television.

PETE AYALA, Airport Police, on 5/28/63, advised he knew subject and his body guard, JIMMY LONGO, but that he had not seen them in a couple of months at the airport. He said a car would drive up and leave an individual off and the car would then drive off, and he was of the opinion LONGO drove subject to the airport on occasions.
