On Tuesday morning, 5/28/63, 2505 Bristol - Protect) advised subject was home on Monday. As previously indicated, subject took TWA flight at 1:15 P.M. on 5/28/63 to Miami.

TP 97-C advised on 6/3/63 that subject must have returned to Tampa, inasmuch as he was at the Columbia Restaurant at 6:00 P.M. on 6/3/63.

Investigation at Tampa International Airport on 6/4/63 through Delta Airlines Manager DICK KNOWLES, R. E. FELLOWFIELD and H. H. SELBY established there were approximately six passengers aboard TWA Flight 550 on 5/28/63, but that five of the passengers were walk-ups which is a common practice at Tampa International Airport and has been for the past six months, inasmuch as there are so many flights between Tampa and Miami and numerous carriers traveling most every hour. They advised passengers common practice in view of the above is to walk up, purchase a ticket, and immediately go aboard the carrier that is leaving immediately after their arrival at the airport. Mr. KNOWLES stated that in view of the above, no passenger records were kept as to true identities of passengers, as they could furnish any name, it being noted that subject's name was not among the six passengers.

In the morning of 6/6/63, (protect) advised SANTO had arrived at 2505 Bristol Ave. on the evening of 6/5/63 and had dinner and was still there at approximately 8:30 P.M. when source left. Source gathered he had just arrived from out of town.

On 6/7/63, PEDRO AYALA, Tampa International Airport Police Chief, telephonically advised the Tampa Office that subject was aboard Delta Airlines flight leaving Tampa 2:38 P.M. to arrive Miami 3:21 P.M. and Miami Office was advised.

On 5/27/63, after 3:00 P.M., SAM TRAFFICANTE was observed driving his vehicle and an unknown male was in the front seat with him, with AUGUSTINE PRIMO LAZZARA in the back seat. They subsequently went to 4510 10th Ave., Tampa which is known as the residence of FRANK DIECIDUE.

On 6/5/63, TP 108-PC advised SAM TRAFFICANTE, PRIMO LAZZARA and the subject visited FRANK DIECIDUE's house, inasmuch as FRANK
