Noting that subject's Falcon arrived at Airport Parking lot at 11:16 PM 6/15/63, it was ascertained that Eastern Airlines Flight 748 departed Miami 11:45 PM 6/15/63. A check of the tickets for this flight which were made available by Mr. C. J. POWERS, Eastern Airlines, reflected no ticket holder with the name TRAFFICANTE. Only three passengers purchased tickets from Miami to Tampa for that flight and were listed as JOE ROGERS, H. C. HEYD and E. JOSLYN. No contact point was listed for ROGERS or HEYD, but JOSLYN's reservation had been made the previous day with the contact point as LO 4-2954. This telephone number is not assigned to Miami, Fla.

Lt. VAN BUSKIRK, Metro Dade County Dept. of Public Safety, Intelligence Division, advised on 6/19/63 that he had observed SANTO TRAFFICANTE at Miami International Airport at 9:45 FM, 6/12/63, but was unable to observe subject's activities further as VAN BUSKIRK was boarding a flight which left immediately. It is noted, as previously reported, subject's car was not listed as being present in the Airport Parking lot on 6/12/63.

On 6/12/63, PCI (protect identity) who is characterized as a businessman who comes in contact with members of the criminal element in the Miami area, advised SA PRUE C. CLINKSCALES that although he did not know what type activities SANTO TRAFFICANTE is currently engaged in, he did learn from a source which he considers reliable that TRAFFICANTE is now paying off some money owed to an unidentified shylock at the rate of \$4,000.00 per month. PCI stated that he had heard some time
