TP 97-C on 6/23 and 24, 1963, advised that the TRAFFICANTE wedding party reservation for Saturday night 6/22/63, was made in the name of "SANTO." Informant advised that the full facilities of the Columbia Restaurant were used for the wedding party of SARAH ANN (TRAFFICANTE) and RICHARD EDWARD VALDEZ. In addition informant advised that during the evening of 6/22/63 he observed the following in attendance:

Informant also advised that SANTO TRAFFICANTE had a party for 32 individuals at the Columbia Restaurant on Sunday, 6/23/63, but was not in a position to observe those in attendance.

On June 26, 1963, [REDACTED] PCI, (Protect) 2505 De Leon St. (maid at 2505 Bristol St., residence of subject) advised that she and her husband attended the wedding of SARAH ANN TRAFFICANTE and RICHARD EDWARD VALDES held at the Sacred Heart Catholic Church at 6:00 p.m. on Saturday, June 22, 1963. Informant stated that she and her husband were the only Negroes in attendance and she did not recall the names of any of the guests at the wedding for she and her husband sat way in the back of the church and left slightly before the processional exiting.

In addition to the foregoing this informant revealed that the TRAFFICANTE family, exclusive of SARAH ANN and RICHARD EDWARD VALDES, left for their summer beach home near St. Petersburg, Fla., on either the night of June 23 or the morning of June 24 where they intend to stay until Sunday July 7, 1963.

Sergeant JACK DE LA LLANA, Intelligence Unit, Tampa PD provided information to the effect that he had heard from sources, JOHN F. DEMMI, local gambler known to the Tampa Division, was in attendance at the wedding reception held at the Columbia Restaurant on June 22, 1963.

On this date Sergeant De La LLANA advised that his department had made a license check of vehicles parked in the lots under the control of the Columbia Restaurant and is presently making a compilation of the registered owners which will be made available to the Tampa Office, who immediately upon receipt will set up communications to have background information obtained on the various owners.

Sergeant De La LLana reported that SAMMY PAXTON, aka Salvatore Amarena, a hoodlum known to Tampa and New Orleans Divisions, was in attendance at the wedding reception and was driving a 1962 Ford yellow convertible with 1963 Louisiana License plates 314-232.

Contained among the license numbers as obtained on the night of June 22, 1963, was Miami tag 1WW-1070,
