WEEKLY AIRTEL SUMMARY

Check of records of Airport Parking Co. of America, Miami International Airport, by SA PAUL A. SCRANTON for period 6/21/63, to 6/28/63, by SA SCRANTON did not reflect presence of white Falcon, 1963 Fla. license 1D-30210.

In connection with investigation in Miami file 92-847, captioned "LOUIS P. BRADY, aka; AR," OO, Chicago, Chicago file 92-1066, the following investigation was conducted at Miami, Fla. by SA C. GRAHAM HURST unless otherwise indicated:

On 6/15/63, at 8:44 P.M., a white Thunderbird bearing 1963 Fla. license 1E-4249, was observed parked at 425 N. W. 88th St., Miami, which is where Mrs. LOUIS P. BRADY resides. This same car was observed at this residence at 9:02 A.M. and 8:44 P.M. on 6/16/63, and at 7:04 A.M. on 6/17/63.

At midnight, 6/27/63, SA JACK LOUIS MARSHALL observed subject TRAFFICANTE and an unidentified male in a 1963 blue Chevrolet, four-door sedan, bearing 1963 Fla. license 1W-43416, at the corner of Northeast 36th Street and 2nd Avenue. This automobile is registered to JAMES M. DUCA, 355 N. W. 47th St., Miami, Fla.

Past investigation by Miami Office has determined that JAMES DUCA was a close associate of MERRILL YARBROUGH, Used Car Dealer, 8945 N. W. 7th Avenue, and on 5/17/63, MM 869-PC advised SA HURST that JIMMY DUCA was formerly a bolita operator in the Miami area and has recently turned his business over to well-known Miami bolita operator TELLMON V. STALLINGS, aka "Foots." MM 869-PC has furnished reliable information in the past and is characterized as an individual who is acquainted with the bolita activities in Dade Co., Fla.

Subject's 1963 white Falcon not observed at his Miami residence during period 6/21/63, through 6/27/63. On 6/26/63, and 6/27/63, a woman believed to be subject's wife was observed by SA PAUL A. SCRANTON at Miami residence.

Further information regarding subject's alleged connection with anti-CASTRO activities was furnished to the Bureau and Tampa by airtel and letterhead memorandum of 6/27/63, captioned, "Ejercito Cubano Anti-Comunista, Frente Escambray, (Cuban Anti-Communist Army) (Escambray Front), IS - Cuba, RA - Cuba," and airtel and letterhead memorandum of 6/25/63, captioned, "The Second National Front of Escambray (SFNE) (Operation Alpha 66), IS - Cuba, RA - Cuba, NM." This matter is being followed closely by the Miami Division.

Miami intends to interview LOUIS CLERICO to determine why BRADY has been in conference with him.
