WEEKLY AIRTEL SUMMARY

ReNYairtel to Baltimore, case entitled "JOSEPH STASSI, aka - FUGITIVE, AR. (OO: NY)" dated 6/26/63.

Reairtel identified subject as former partner with JOSEPH STASSI in Sans Souci Casino, Havana, Cuba and that subject also met STASSI at the Stage Delicatessen, New York City, in 11/62. Reference reported Bureau instructions set out that associates of subject were to be interviewed unless information contained in covering field office files precludes contact, and unless common sense dictates, leads are to be covered in 48 hours.

Newark office advised Bureau and Tampa, 6/19/63, that on 6/15/63, NK 2251-C* advised ANGELO DE CARLO, Newark top hoodlum, gave ANTHONY "PUSSY" RUSSO \$200.00. The money was a wedding present for SANTO's daughter in Florida.

Inquiry GLORIA HACKWORTH, 4518 Eden Roc Road, Tampa, who was reported on an airline flight from Miami to Tampa with FRANK RAGANO, who was on the same flight, determines she is a secretary to law firm attorneys SASSER and DANAHY and was previously employed for many years with other Tampa law firms. Check of residence telephone toll calls failed to develop anything of significance.

TP 105-C* at St. Petersburg Beach, Fla., indicates subject's daughter and son-in-law, Mr. and Mrs. AUGUST PANIELLO, and child, apparently vacationing 3610 El Centro, St. Petersburg Beach, Fla. and there, are visited by friends. Surveillance and confidential source do not place subject there.

On 7/3/63, subject's 2505 Briston residence observed to be closed and no cars there. Same date, HERB GOLDBURG, next-door neighbor, advised subject nor family have been seen at 2505 Bristol.

On 7/3/63, [redacted] an attorney, PCI (protect), advised he understood from sources that the TRAFFICANTE Family was broke; that the parties held at the Columbia Restaurant, concerning the wedding of SARAH ANN TRAFFICANTE had not been paid for and CESAR GONZSMART was worried. Source related neighbors in vicinity Dream Bar, Nebraska Ave., which property and bar operated by TRAFFICANTE Family, got up petition to have bar pave a parking area about the property and an attorney understood (this attorney was representing such group) that the TRAFFICANTES could not get anyone to pave the area as they wanted cash and there was none available.

Subject has not been seen nor reported in Tampa and last known to be in company of JIMMY DUCA, midnight 6/27/63 in Miami.

BRADY and he drove off in a 1959 white Chrysler, 1963 Florida license 3W-6338, noting such vehicle usually always in Tampa and used by subject's daughter. This airtel also reported subject seen at midnight 6/27/63. Miami requested to clarify above.
