on April 8, 1963, EM1-1561, was identified by General Telephone Co. of Florida source as being a working number on Key Biscayne, Miami.

On July 10, 1963, TP 120 PCI advised subject, wife and family were at 2505 Bristol Avenue on the afternoon of Monday, July 8, 1963, and SANTO was at residence in Tampa the evening of July 9, 1963, when source left. Source advised 1959 white Chrysler which bears 1963 Florida license 3W-6339 in Tampa.

The following license tags and registration of vehicles were furnished by Sergeant JACK DE LA LLANA, Tampa PD, which he advised he obtained in coverage of the wedding June 22, 1963, as set out above.
