THIRTEENTH LAST PCI [REDACTED] ADVISED HE HAD

SEEN CONTRACT SHOWING JOSE D. HERNANDEZ SANTA CRUZ, EUGENIO LEAL POZO, AND JAIME PASESUNSKY AS LESEES GAMBLING CASINO IN PAN AMERICANA HOTEL, FORMERLY HISPANOL HOTEL, AND PREVIOUSLY KNOWN AS LA PAZ HOTEL, SANTO DOMINGO, D.R. LESSOR IS BERNARD FLORES, DOMINICAN NATIONAL WHO HAS LICENSE FOR CASINO. PCI HAS HEARD RUMOR TRAFFICANTE MAY BE INVOLVED WITH ABOVE BUT DOUBTS THIS BECAUSE ABOVE CUBANS TRYING TO BORROW MONEY IN MIAMI AND APPEAR TO BE WORKING AGAINST INTERESTS OF LESLIE KRUSE. PCI OBSERVED KRUSE ARRIVE MIAMI AIRPORT FROM CHICAGO ON TWELVTH LAST WHERE MET BY CHAUFFER AND INDIVIDUAL KNOWN TO PCI AS NICKNAMED CHOPPER WHO IS ALLEGED TO BE ERRAND BOY FOR TRAFICANTE.
