JOE CRENSHAW, EAL, ALL STATION MANAGERS RESPECTIVE AIRLINES, ADVISED A.M. TODAY COULD LOCATE NO CONTINUING NOR RESERVATIONS FOR A. T. STRONG. AIRPORT PERSONNEL ALERTED FOR SUBJECT.

BY TEN THIRTY A.M. TODAY, BOTH FORD AND CHRYSLER NOT PRESENT TAMPA RESIDENCE, HOWEVER, FORD OBSERVED BEING DRIVEN BY AUGUST PANIELLO ALONE TODAY. JAMES C.
