Mr. OSCAR WEBER, Chief of Detectives, Geneva, Switzerland, advised on 1/25/61 that while the subject was staying at the Hotel Richemond, Geneva, he was in contact with one EDMOND COHEN, a French National, who resides at Istanbul, Turkey. According to Mr. WEBER, COHEN visits the Hotel Richemond frequently but the Geneva Police have no prior information regarding him and know nothing of his Suitactivities. He has not come to their attention before and the significance of his contact with ALEX is unknown.

He stated that ALEX was also in touch with one PAUL BINER, who is a superintendent of a business building in Geneva. ALEX telephoned BINER and BINER came to the hotel to see ALEX. Mr. WEBER stated that BINER likewise has not come to the attention of the Geneva Police previously and the significance of this contact is likewise unknown.
