GUS ALEX, AKA., AR. DAILY SUMMARY. IN CONNECTION WITH THE ~~NATIONAL~~ MAINTENANCE CORPORATION IN WHICH CORPORATION ALEX IS ALLEGED TO HAVE AN INTEREST, CG SIX FOUR FOUR THREE DASH C STATED THAT ~~BEN STEIN~~, PRESIDENT, IS A FRONT FOR THIS ORGANIZATION FOR THE QUOTE OUTFIT UNQUOTE.

HE STATED THAT ABOUT A YEAR AGO BEN STEIN HID OUT IN THE BASEMENT OF HIS HOME BECAUSE THE OUTFIT WAS GOING TO KILL STEIN.
