*pr* CG SIX TWO SEVEN TWO DASH C ADVISED THAT HE HAS KNOWN ALEX TO FREQUENT THE MAYO CLINIC AT ROCHESTER, MINNESOTA, FOR PHYSICAL CHECKUPS IN THE PAST. HE STATED THAT IS HIS OPINION THAT ALEX/S HEALTH HAS BEEN AGGRAVATED BY RECENT INVESTIGATION OF THE ACTIVITIES OF ALEX BY THE FBI. HE STATED THAT ALEX HAS A HEART CONDITION AND IS TROUBLED PERIODICALLY BY ULCERS. CG SIX FOUR FOUR SIX DASH C ADVISED THAT HE RECENTLY HAD BEEN IN CONTACT WITH GUS LIEBE AND THAT IT IS HIS OPINION THAT LIEBE WORKS ON A BONUS ARRANGEMENT AT THE J AND J PICNIC GROVE, A LARGE GAMBLING OPERATION IN WILL COUNTY ILL., JUST OUTSIDE THE SOUTHWEST BOUNDARY OF COOK COUNTY. HE STATED IT WAS HIS OPINION THAT FINANCIAL CONTROL OF THE J AND J OPERATION WAS HELD BY ALEX, FRANCIS CURRY, SAM GIANCANA, FRANK LA PORTE AND ROCCO FISCHETTI. HE STATED THAT THIS IS CURRENTLY ONE OF THE LARGEST GAMBLING OPERATIONS IN THE AREA OF CHICAGO. HE STATED THAT SEVERAL YEARS AGO THE SAME TYPE OF OPERATION WAS SETUP IN DEERFIELD, ILL.

AND AT THAT TIME LIEBE ARRANGED THE BANKROLLING AND HAD A TEN PER CENT CUT OF ALL PROFITS. HOWEVER, SHORTLY AFTER THE OPERATION WAS SETUP THE OUTFIT PLACED SOME OF THEIR MEN AS EMPLOYEES AT THE OPERATION WITH CROOKED CARDS AND DICE AND CAUSED THE OPERATION TO LOSE MONEY. BASED ON THIS MANEUVER THE OUTFIT CHASTISED LIEBE FOR LOSING MONEY AND CUT HIS PERCENTAGE DOWN TO FIVE PER CENT. THEY THEN PULLED OUT THEIR MEN AND THE OPERATION BEGAN MAKING MONEY AGAIN.
