Sher Wagner, ONE TWO THREE E. FIFTY SEVENTH ST., NEW YORK. INVESTIGATION CONTINUING TO DETERMINE IDENTITY OF SHERLE WAGNER. INFORMATION PREVIOUSLY REPORTED THAT ALEX WAS SEEN ON STREET WITH GEORGIA DRAKE, NIGHT CLUB SINGER.
