BILLIARD PARLOR AND RESTAURANT ON SOUTH STATE STREET. HE SAID THAT AFTER A FAST COURTSHIP, HELEN WAS MARRIED TO ARGER, HOWEVER, IN HIS OPINION THIS MARRIAGE WAS A MISTAKE AND ONLY LASTED FOR A SHORT TIME WHEN HIS SISTER SECURED A DIVORCE FROM ARGER.
