REMYTEL YESTERDAY.

RE KILLING OF BENJAMIN F. LEWIS, ALDERMAN, CHICAGO TWENTY FOURTH WARD. CG SIX TWO EIGHT THREE DASH C, WHOSE BACKGROUND IS STRONGLY LINKED WITH THE TWENTYFOURTH WARD, ADVISED TODAY THAT THE POLITICAL UPHEAVAL IN THIS WARD HAS BEEN INCREASING IN MAGNITUDE FOR THE PAST EIGHT MONTHS. ALDERMAN LEWIS HAD BEEN RUNNING ROUGHSHOD OVER THE WISHES OF THOSE POLITICALLY POWERFUL INDIVIDUALS WHO CONTROLLED THIS AREA WHEN IT WAS CAUCASIAN SUCH AS PRESENT CIRCUIT JUDGE ABRAHAM MAROVITZ, DEMOCRATIC NATIONAL COMMITTEEMAN JAKE ARVEY AND OTHERS OF SIMILAR STATURE, AND HAD BEEN DEMANDING THE POLITICAL PATRONAGE FOR THE NEGROES IN HIS LEWIS MACHINE. THE INFORMANT ADVISED HE DID NOT HAVE ANY SPECIFIC INFORMATION AS TO WHETHER OR NOT THE MURDER, IN FACT, WAS COMMITTED FOR THIS REASON.
