DE TOLVE is also the brother-in-law of GIANCANA. The reference to "them guys out south" is a reference to the hoodlums associated with MURRAY HUMPHREYS. From the conversation, it is obvious that D'ARCO was originally supported by HUMPHREYS when he ran for Alderman eight years ago. It would appear, however, that D'ARCO is extremely reluctant to approach HUMPHREYS in regard to enlisting his support against GIANCANA and it would also appear that GIANCANA has much more power concerning political appointments than does HUMPHREYS even though heretofore it has been felt by the Chicago Office that HUMPHREYS more or less had the final say in regard to political affairs. From the above it would appear that GIANCANA does not need the approval of any other Chicago top hoodlum in order to make or break public officials and politicians.

The reference to "TISH" is apparently a reference to ANTHONY TISCI. TISCI is a Chicago public official who has offices at 1 North LaSalle in Chicago and who is sponsored by D'ARCO but is extremely close to GIANCANA.

The reference to QUILICI is a reference to Judge GEORGE QUILICI who for years was a municipal judge but who was elected last month to the Superior Court of Cook County. Apparently GIANCANA ordered D'ARCO to elect QUILICI "or else." It is noted\_that QUILICI won a heavy majority of votes in the First Ward last November.

The reference to "CAPONE's son's restaurant in Florida" is a reference to the restaurant operated by SONNY CAPONE in Miami Beach.

The reference to POPE is a reference to the now deceased Judge POPE of the Superior Court of Cook County.

The reference to PORKY is a reference to JOSEPH PORCARO, who is the Republican Ward Committeeman of the 28th Ward. It is noted that CG 6498-PC recently advised that he met with GIANCANA surreptitiously in a restaurant in North Riverside, Illinois. It was GIANCANA's purpose to request the PCI to support PORCARO in the 28th Ward for Alderman of that Ward. It is noted that this PCI is the primary political power in the 28th Ward. CG 6498-PC advised that he has known for many years that PORCARO is supported by TONY ACCARDO, who is referred to above as "JOE B."
