[redacted] is an informant of the Chicago Division. The situation referred to above could possibly refer to the recent visit of WILLIAM G. HUNDLEY, Chief of Organized Crime and Racketeering Section, who was recently in Chicago and could possibly be that person who is referred to in this conversation as BOBBY KENNEDY. There is a strong possibility that the reference to furnishing the "President all they got in writing" is probably a reference to a recent letterhead memorandum prepared by the Chicago Division containing all information available in that Division pertaining to the situation surrounding the First Ward activities. In evaluating this information it has been noted that the contacting Agent for this informant has not contacted him since the preparation of this memorandum and for that reason there would be no possibility of that information coming to LIEBERMAN's attention from the Chicago Office.

SORRENTINO mentioned in the conversation would be identical to Judge PASQUALE SORRENTINO, who is also a close friend of those persons within the First Ward organization.

To further substantiate the possibility of information contained in the above-mentioned memorandum having been leaked out is the fact that this individual is aware of the Government's interest in the activities of certain judges within the Chicago area which information has been maintained in an extremely confidential manner even within the Chicago Division and it is felt that the only possible way that this information would be known would be through a leak from another source, in this instance the office of the USA.

At approximately 4:30 p.m., 12/18/62, the individual referred to as BILL in my airtel of yesterday, who was engaged by PAT MARCY to check the phones within the offices of the First Ward reappeared in MARCY's office, at which time a discussion lasting approximately five minutes was held between

the two individuals. This discussion was held in extremely low tones and only minor excerpts could be obtained from the source. From the limited amount of information available it is known that this individual advised MARCY that his telephones are not tapped at any point within the building. Again due to the low tones used by BILL, it is pointed out that the full context of the conversation could not be determined; however, it is strongly felt that MARCY received no indication from this individual of any possible microphone installations within his offices. At the termination of their conversation MARCY was overheard to state to this individual that "If I want any work done I will get in touch with DICK and have him get in touch with you." This reference to DICK was felt to be a reference to RICHARD CAIN, presently one of the top investigative aides of Cook County Sheriff RICHARD OGILVIE who is known to be associated with PAT MARCY as per previous airtels. A pretext telephone call was made to the Sheriff's Office and a request made to talk to "BILL, DICK CAIN's partner." It was determined that BILL was not in and under further pretext it was determined that BILL WITSMAN is presently CAIN's number one partner or aide. It is pointed out that CAIN has a reputation for being an excellent wire tap man and in fact an article appearing in Chicago newspapers on 12/18/62 indicated that CAIN had recently made a check of phones within the Sheriff's Office and uncovered six tapped lines within this building. Chicago continuing to watch this situation closely concerning the security of CG 6576-C\*.

For the further information of the Bureau, [redacted] [redacted] is CG 6283-C and is a practicing attorney with offices at 100 North LaSalle where Chicago's First Ward organization is located. [redacted] is also the attorney for Anco Insurance Company with which D'ARCO and others are connected and is also the personal attorney to PAT MARCY and CHARLES NICOSIA, a member of D'ARCO's office staff. LIEBERMAN also shares office space with MARTIN GERBER, a former Chicago AUSA, and is in frequent contact with D'ARCO and members of his organization. Because of this relationship [redacted] is in a good position to know the comings and goings of Chicago's First Ward organization as well as developments at the USA's Office in Chicago.
