CARUSO's first statement in regard to the fact that he "got the three coppers that were in on the pinch, the three lawyers, etc." is not clear enough to the reviewing agents to determine whether he is referring to a payoff to these individuals or not. It is pointed out later in the conversation, however, that MIKE BRODKIN advised CABUSO that one of the coppers in the pinch has to be paid a C note. The reference to the "fat guy" is to JAMES VO'REILLY, an individual who is currently an informant of the Chicago Office and who was utilized by the States Attorney in this case in an attempt to develop sufficient evidence to afford prosecution to the individuals arrested in this raid.

The judge who was given \$500 for his role in this case is apparently identical to Judge DAN J. RYAN who was the presiding judge at the trial and who it is known through previous information furnished by this source to be extremely close to MARCY and an individual who has been known to do favors for pay for MARCY in the past, especially in connection with trials concerning First Ward strip joint arrests. KUP referred to by MARCY would be identical with IRVAKIPCINET, columnist for the "Chicago Sun Times" who has made mention on several occasions in his column recently of the fact that there was more to the switch of Alderman in the First Ward than the First Ward Democratic organization was releasing for publicity, The KORSHAK mentioned in this regard is probably SIDNEY KORSHAK who is well known to the Bureau and who is a close friend Later in the day ART PETACQUE, a reporter for Z// of KUPCINET's. the "Chicago Sun Times", met with MARCY at which time MARCY told him to get in touch with KUPCINET and advise him that he was not making any friends and there was a strong likelihood that ANTHONY DETOLVE would institute libel proceedings against KUPCINET. MARCY requested that PETACQUE recontact MARCY at such time as he was able to determine the attitude of KUPCINET upon learning of this information.
