CG 6533-C ADVISED THAT GIANCANA OBSERVED BACK IN CHICAGO AREA ON MAY 1 LAST IN COMPANY OF BUTCH BLASI. ADDED THAT GIANCANA HAS BEEN OBSERVED ON DAILY BASIS SINCE THAT DATE IN COMPANY OF NUMEROUS INDIVIDUALS AT ARMORY LOUNGE. IT APPEARS ARMORY LOUNGE CONTINUES TO OFFER EXCELLENT POTENTIAL. (U)

CONTEMPLATED REENTRY INTO ARMORY LOUNGE FOR PURPOSE OF RELOCATING AND IMPROVING CONFIDENTIAL COVERAGE PLANNED FOR MAY 5 INSTANT POSTPONED PENDING ADJUDICATION OF GIANCANA LEGAL PROCEEDINGS TO BE HEARD MAY 7 NEXT. IT IS POINTED OUT THAT TO INSURE PROPER COVERAGE AND FULL SECURITY FOR REENTRY CHICAGO WOULD BE REQUIRED TO CONDUCT A SURVEILLANCE OF GIANCANA WHICH MIGHT POSSIBLY JEOPARDIZE FORTHCOMING HEARING. BUREAU WILL BE KEPT ADVISED AS TO CHICAGO'S PLANS RE ARMORY. (U)
