DETECTIVE JACK DE LA LLANA, TAMPA PD ADVISED JULY SEVENTEEN THAT INTELLIGENCE BUREAU, MIAMI PD HAD DEVELOPED SOME INFORMATION THAT A RICHARD, DAN J. AND ROBERT TRAFFICANTE ALLEGEDLY RESIDE, ACCORDING TO MIAMI CITY DIRECTORY AT FIVE NINE NAUGHT NINE S. W.
