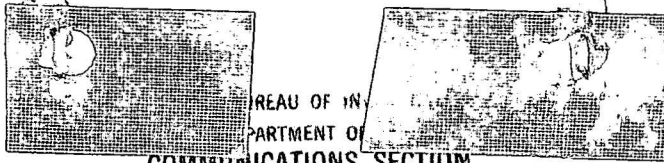

SANTO TRAFFICANTE, JR., AKA, AR. DAILY TELETYPE. HERBERT GOLDBURG, ASSISTANT STATE ATTORNEY, TAMPA, WHO IS BUILDING RESIDENCE IMMEDIATELY ADJACENT TO THAT OF SUBJECT, ADVISED JULY TWENTY THAT FRANK RAGANO, SUBJECT ATTORNEY, MENTIONED TO HIM THAT SUBJECT WAS VERY CONCERNED OVER GOLDBURG-S BUILDING NEXT TO HIM, THAT HE WAS OF OPINION STATE OF FLORIDA PURCHASED LOT FOR GOLDBURG SO THAT GOLDBURG COULD OBSERVE SUBJECT-S ACTIVITIES. RAGANO TOLD GOLDBURG SUBJECT SAID THAT SUBJECT PROBABLY HAD FRIENDS WHO WOULD BE NERVOUS TO COME TO HIS HOUSE FOR A BARBEQUE AS THEY WOULD ALL BE OBSERVED NOW BY GOLDBURG. TP FORTYONE P C ADVISED NIGHT OF JULY NINETEEN, A SOURCE TOLD HIM SUBJECT WENT TO EITHER NEW YORK OR MIAMI, MODE OF TRAVEL UNKNOWN, BUT THAT FORTYONE P C DID NOT BELIEVE SOURCE TOO RELIABLE AND CONSIDERED PERSONS MAY BE TESTING HIM TO SEE IF FBI CHECKS AIRLINES. FORTYONE P C AS OF JULY TWENTY WAS TO CONTACT AUGUSTINE PRIMO LAZZARA CONCERNING SUBJECT.
