SUBJECT HAS FIVE THOUSAND DOLLAR TWENTY YEAR ENDOWMENT POLICY WHICH POLICY LAPSED SEPTEMBER EIGHT, SIXTY, WHEN PREMIUM WAS DUE AND WAS NOT PAID.
