## INFORMANTS

On the afternoon of 12/5/63, former MM 722-C telephonically advised SA PRUE C. CLINKSCALES in Miami that on that morning as he was checking into the New York Hilton Hotel, he observed ALDERISIO along with IRV WEINER, both of Chicago, checking out of the New York Hilton Hotel.

On 12/30/63, Mr. ROBERT C. DONALDSON, Credit Manager, New York Hilton Hotel, 1335 Avenue of the Americas, New York City, made available the registration card of IRVIN S. WEINER, 1019 South State Street, Chicago, Illinois. According to this card, WEINER is affiliated with the American Bonding Company. WEINER was assigned Suite 4036-37-38. The card indicated a party of two persons would occupy the suite. The party registered on 12/2/63, at 10:00 A. M., and departed at 9:58 A. M., 12/5/63. The card indicated two persons departed.

The hotel folio on IRVIN S. WEINER and party reflected the following charges: Phone, \$1.00; Room, \$79.00; City Tax, \$3.95. The total charges were \$83.95.

According to DONALDSON, the phone call was a local call and no record of these calls is maintained by the hotel. A check of the registration cards for ALDERISIO and his aliases was negative.

Since it appears that none of the data listed above would be helpful in any prosecution against ALDERISIO, it is not being included in the Details. Chicago may desire to include it in reports on their anti-racketeering case regarding ALDERISIO.
