It is called to the Bureau and Miami's attention that the information furnished by CG 6588-C-TE is not to be divulged to any unauthorized person inasmuch as ALDERISIO has only furnished this information to this informant and should the same get back to ALDERISIO, this informant would be killed.

It is also called to the attention of the Bureau and Miami that the information furnished by [redacted] should not be divulged to any unauthorized individual because [redacted] at the present time, is employed indirectly by IRVIN WEINER, who is a close associate of ALDERISIO.
