For the information of the Bureau, Los Angeles by airtel to Miami dated 1/7/64 in captioned matter advised that MORRIS LITBERG is identical to an LA-C-TE who resides in the Los Angeles Division and who has refused to testify against ALDERISIO.

It is to be noted that in connection with the case captioned "FELIX ALDERISIO, aka, AR, (Bufile 92-3241)", various individuals have been interviewed to ascertain if they would testify against ALDERISIO and in each instance they have advised they would not.

The Chicago Division is not at this time submitting reports reflecting interviews of MORRIS LITBERG due to LITBERG being identical to an LA-C-TE who has refused to testify. It is to be noted, however, that the results of these interviews have previously been submitted in connection with the case captioned "FELIX ALDERISIO, aka, AR, (Bufile 92-3241)".

ALDERISIO AND TRAFFICANTE SHOULD BE CONSIDERED ARMED AND DANGEROUS.
