A confidential source advised that Irvin Veiner bas now taken over the office of the Eureau of Liquidation, Illinois State Department of Insurance. This was accomplished by the resoval of Mr. Albert Verb, after which Veiner was influential in placing Clarence E. Walley and Frances Tague in this office. This confidential source further advised that on January 9, 1964, Irvin Veiner placed a clerk, Patricia Weffett, who resides in Dewners Grove, Illinois on the staff of the Eureau of Liquidation, Illinois State Department of Insurance, Chicago.

This confidential source stated that following Halloy and Tague assuming the responsibilities of the direction of the Dureau of Liquidation they immediately asked such questions as the identity of the various government agencies who have made inquiry, and have reviewed the records of the Central Casualty Company. They also asked as to whather these files contained information that in any way implicate Irvin Voiner in regards to this matter. This confidential source pointed out that he is of the opinion that Mailoy and Tague are in the office of the Sureau of Liquidation solely to protect the interest of Irvin Voiner. This source pointed out that the name of Folix Alderials has not been discussed to date by either Mailoy or Tague.

Another confidential course advised on December 13, 1969, that Felix Alderisio is instructing his associates that it is all right to threaten people, but do not hit them. This source advised that he is of the opinion the word "people" in this statement includes FBI Agents.

This Bureau has received the following information on an extremely confidential basis concerning the activities of Felix Anthony Alderieio:

Within the past few weeks Alderisio is reported to have requested one of his associates to accompany him, Alderisio, to Florida for the indicated purpose of breaking an arm or leg of a banker identified as James V. Egan, and thereby preventing Egan from testifying against Alderisio.

The associate of Alderisio's is believed to have declined this request as he was afraid to get deeply involved in the activities of Alderisio. The source of this information has described Alderisio as a violent and vicious; man who would not permit anyone to stand in his way.
