It is also to be noted that the additional confidential source referred to in the attached LHM makes reference to CG 6714-C.

Miami should hand carry the attached LHM to Departmental Attorney PELOQUIN in accordance to prior Bureau instructions.

ALDERISIO AND TRAFFICANTE SHOULD BE CONSIDERED
