### At Miami, Florida:

Will attempt to arrange an early conference with Departmental Attorney, ROBERT D. PELOQUIN, in order to determine if he desires additional investigation conducted since the trial is now scheduled for October 20, 1964. Will discuss results of investigation at Denver with Departmental Attorney, ROBERT D. PELOQUIN, for the purpose of ascertaining whether or not JOHN MARINO and ROCCO J. BONOMO, both of Denver, Colorado, should be interviewed as to message reported to have been delivered to HUGH BEST by MARINO and which related to an attempt to have JAMES W. EGAN contact ALDERISIO's attorney at Denver and furnish affidavit repudiating information previously furnished by him in order to avoid any future difficulty.

## CHICAGO, DENVER and LOS ANGELES:

Information copies are furnished these offices who have an interest in the case.

Los Angeles Office is requested to place data received from LA 4410-C-TE into a letterhead memorandum bringing up to date all of the data he has about captioned case.

#### -INFORMANTS-

LA 4410-C-TE advised the following on June 25, 1964:

Acting on instructions to attempt to determine additional information concerning captioned Miami case, he was able to learn from Chicago source whom he declined to name, but characterized as persons who were in a possible position to pick up conversations from the hoodlum element, EGAN (JAMES WILLIAM EGAN) was reportedly not going to appear or has been straightened out in regard to ALDERISIO's matter under prosecution in Miami. He was unable to obtain any additional information.
