MARINO insisted that he had no knowledge as to the discussion leading to STEIN's request that BISTERFELDT contact ERICKSON and consequently would have no idea as to what such a meeting would accomplish nor did he know whether or not BISTERFELDT had ever made such a contact.

Mr. MARINO stated that he would make a search of his personal records in an attempt to determine the exact dates when STEIN was in Denver as well as the date that he was in Chicago and signed the affidavit and the date when he telephonically contacted STEIN and on which occasion STEIN requested that he contact EGAN and request him to get in touch with Attorney ERICKSON and that when this information was located, he would notify the Denver Office.
