On 10/5/64 a phone call was received by the Los Angeles Office from BILL KENNY, Departmental Attorney, calling from Miami. Subpoenas had been issued for [redacted] (LA 4410-C-TE) and [redacted] for appearance in U.S. District Court, Miami in the ALDERISIO trial.

The U.S. Marshal, Los Angeles, had apparently been unable to locate [redacted] for service and KENNY asked for the current whereabouts of [redacted], since 9030 West Pico Boulevard, Los Angeles was apparently an old business address. In this regard KENNEY was referred to the Miami Office and he said he would contact that office for the desired information.

For the information of Miami, LA 4410-C=TE has been unable to furnish any information of value for the past several months due to opening a new wholesale bakery and spending long hours at this work. It is possible he may be unable to continue as an informant and will probably have to be closed.

[redacted] continues to reside at 2029 South Garth, Los Angeles and his bakery operation is located at 1583 Colorado Eagle Rock, in the greater Los Angeles area. At both of these locations he is [redacted]
