SAMUEL M. GIANCANA, AKA. AR. ANTIRACKETEERING

HONOLULU DIVISION ADVISED INFORMATION RECEIVED JANUARY 2 LAST FROM JERRY JOHNSTON, WAIALAHA COUNTRY CLUB, HONOLULU, THAT SUBJECT USING NAME OF FLOOD, RECOGNIZED BY JOHNSTON PLAYING GOLF ON THAT DATE WITH THREE ASSOCIATES. JOHNSTON STATED SUBJECT REPORTEDLY PLAYED GOLF AT SAME CLUB DECEMBER 30 AND 31 LAST. ON 31ST, SUBJECT REPORTEDLY PLAYED WITH JOE DI MAGGIO, AS GUEST OF ONE S. ROSIE WITH WHOM HE HAS PLAYED ON OTHER DATES. ROSIE'S IDENTITY UNKNOWN. A FOURTH INDIVIDUAL WHO ACCOMPANIED GIANCANA ON PREVIOUS TRIP TO HAWAII AND WHO GAVE NAME AS JAMES GRANGE, ALSO PLAYING GOLF WITH SUBJECT.

RICHARD D. FLOOD AND WIFE, 592 WEST ADAMS STREET, CHICAGO, AND JOHN FLOOD AND WIFE, 847 MADISON AVENUE, NEW YORK CITY, CHECKED INTO KAHALA HILTON HOTEL, HONOLULU, JANUARY 1 LAST, AFTER RESERVATIONS HAD BEEN MADE DECEMBER 30 LAST. FLOOD BELIEVED TO HAVE STAYED IN ANOTHER HOTEL, HONOLULU, PREVIOUS TO ARRIVAL AT KAHALA HILTON. THE FLOODS, IN THEIR RESERVATIONS, HAVE EXPRESSED INTENT TO REMAIN IN HONOLULU UNTIL JANUARY 14 NEXT.

IT IS POINTED OUT THAT ROSE FLOOD, SISTER OF GIANCANA, RESIDES 5924 WEST ADAMS STREET, CHICAGO.

FOR INFORMATION HONOLULU, CG 6533-C, WHO IS ACQUAINTED WITH SUBJECT, ADVISED SUBJECT BELIEVED SEEN DURING MORNING HOURS, DECEMBER 31 LAST AT ARMORY LOUNGE, FOREST PARK, ILLINOIS. SUBJECT
