GUS ALEX, AKA, AR. DAILY SUMMARY. CG SIX FOUR FOUR THREE C ADVISED THAT

THE ASSOCIATION BETWEEN GUS ALEX AND LOUIS ARGER STARTED SOME TWENTY
THREE YEARS AGO WHEN ARGER OWNED A LITTLE CLUB WHICH WAS LOCATED WHERE
THE PRESENT DAY HOLIDAY LOUNGE NOW STANDS ON STATE STREET. ARGER WAS
A PARTNER OF ONE JOE BOVIDO AT THAT TIME. THE ITALIAN ELEMENT OF
THE QUOTE OUTFIT END QUOTE ATTEMPTED TO MUSCLE ARGER AND BOVIDO OUT
OF THEIR CLUB. ARGER WENT TO SEE GUS ALEX AT THE BLUE ARROW, WHICH
AT THAT TIME WAS LOCATED ON TWENTY SECOND STREET. ARGER PROTESTED
TO ALEX REGARDING THE MUSCLING ATTEMPTS BY THE ITALIAN ELEMENT. ALEX
AGREED TO PROTECT ARGER, SO HE COULD RETAIN HIS CLUB FOR A FEE
OF TWENTY PERCENT OF THE PROCEEDS OF ARGER-S CLUB. INFORMANT SAID THIS
WAS A UNIQUE AGREEMENT BETWEEN ALEX AND ARGER AND IS STILL IN EFFECT
TO THIS DATE. INFORMANT ADVISED THAT BOVIDO IS STILL ASSOCIATED WITH
ARGER IN HIS ENTERPRISES ON SOUTH STATE STREET AND THAT BOVIDO-S
WIFE, WHO FREQUENTS THE HOLIDAY LOUNGE, KEEPS THE BOOKS FOR ARGER
REGARDING THE HOLIDAY LOUNGE AND ARGER-S OTHER INTERESTS ON SOUTH
STATE STREET. IT IS TO BE NOTED THAT ATTEMPTS WERE MADE TO INTERVIEW
ARGER BUT HE REFUSED TO BE INTERVIEWED STATING HE HAD NOTHING TO SAY
