You should follow this matter closely in order to ascertain full details at the earliest feasible time concerning the information furnished by CG 6498-PC indicating that Giancana is aware that information previously discussed between him and the informant had come to the Bureau's attention.

Advise the Bureau promptly of pertinent developments in this matter.

NOTE: CG 6498-PC advised he had a meeting with Giancana 2/5/64 during which time Giancana pointedly inferred that information he previously discussed with informant had come to the attention of the FBI. No details were furnished by the informant who indicated that he did not wish to furnish them at that time. Chicago is being instructed to follow this matter and obtain further information as soon as possible and advise the Bureau.
