SAMUEL M. GIANCANA, AKA, AR. ANTIRACKETEERING

CG 6498-PC ADVISED HE WAS CONTACTED BY GIANCANA ON FEBRUARY 5 LAST AND TOLD TO MEET THAT DAY WITH GIANCANA. DURING MEETING GIANCANA LET INFORMANT KNOW THAT FBI AWARE OF INFORMATION DISCUSSED BETWEEN INFORMANT AND GIANCANA ON PREVIOUS OCCASION. NO THREATS MADE AND INFORMANT NOT OVERLY CONCERNED, HOWEVER, STATED GIANCANA MADE INFERENCE VERY POINTED. FULL DETAILS NOT OBTAINED AS INFORMANT DID NOT WISH PERSONAL MEETING AT THIS TIME AND DID NOT DESIRE TO TELL FULL DETAILS ON PHONE. NO DETAILS AVAILABLE AS TO CONTENT OF INFORMATION KNOWN TO GIANCANA NOR HOW HE MAY HAVE LEARNED OF FBI'S KNOWLEDGE. INFORMANT BEING CONTACTED AS SOON AS FULL SECURITY CAN BE ASSURED.

GIANCANA, BUTCH BLASI, AND JOHN MATASSA OBSERVED TOGETHER AT ARMORY LOUNGE DURING LATE EVENING HOURS FEBRUARY 6 LAST DURING SPOT PHYSICAL SURVEILLANCE.

CG 6576-C* ADVISED LOUIS ARGER MET WITH PAT MARCY FEBRUARY 6 LAST TO COMPLAIN OF CONTINUED ARRESTS BY FIRST DISTRICT POLICEMEN OF ARGER'S ESTABLISHMENTS. ARGER STATED CAPTAIN JAMES RIORDAN MADE ARRESTS ON EVENING OF FEBRUARY 5 LAST. ARGER EXTREMELY UPSET AND WANTS MARCY TO CRACK DOWN. AS HE TOLD MARCY "AFTER ALL YOU ARE THE ONE WHO RUNS FIRST WARD." MARCY TOLD ARGER THAT "EVERYONE IS SCARED NOW LOUIS AND THEY
