SAMUEL M. GIANCANA, AKA, AR.

CG 6498-PC ADVISED ON FEBRUARY 11 LAST THAT MEET WITH GIANCANA SET FORTH IN MYTEL OF FEBRUARY 8 LAST HELD AT TOPPERS RESTAURANT LOCATED ON WEST SIDE IN CHICAGO. INFORMANT ADVISED MEETING HELD IN DAYLIGHT HOURS AND WAS SUPRISING IN NATURE TO INFORMANT IN THAT GIANCANA MET WITH HIM AT BAR WHICH IS IN CLEAR VIEW OF ENTIRE RESTAURANT. ALSO SUPRISING TO INFORMANT WAS UTILIZATION OF THIS RESTAURANT WHICH IS SITUATED VERY CLOSELY TO WARD OF WHICH HE IS COMMITTEEMAN, THEREFORE GIVING STRONG POSSIBILITY TO PERSONS ACQUAINTED WITH INFORMANT BEING PRESENT IN THE LOUNGE AND OBSERVING SUCH A MEET. U

INFORMANT ADVISED THAT GIANCANA MENTIONED TWO SITUATIONS WHICH HE, GIANCANA, FELT FBI WAS AWARE OF, WHICH SITUATIONS HAD BEEN DISCUSSED BETWEEN GIANCANA AND INFORMANT. THESE WERE, IN THE WORDS OF THE INFORMANT, "THE CONGRESSIONAL SITUATION AND THE 36TH." THESE UNDOUBTEDLY REFER TO THE SITUATION CONCERNING RECENT PUBLICITY ATTENDANT UPON RESIGNATION OF CONGRESSMAN ROLAND LIBONATI AND HIS REPLACEMENT BY FRANK ANNUNZIO WHICH HAS BEEN REPORTED FULLY IN LOCAL NEWSPAPERS. IT WAS POINTED OUT TO INFORMANT THAT THIS SITUATION HAD NOT BEEN DISCUSSED WITH THE INFORMANT. J

REFERENCE TO THE "36TH" IS FELT TO BE A REFERENCE TO SITUATION CONCERNING 36TH WARD AND COULD BE ONE OF TWO THINGS. THE FIRST OF THESE COULD BE REFERENCE TO FACT THAT FBI IS AWARE OF ATTEMPTS
