GIANCANA OBSERVED AT ARMORY LOUNGE THIS DATE BY CG 6533-C. INFORMANT ADVISED THAT INDIVIDUAL CARRIED LARGE FIXTURE OF SOME TYPE INTO LOUNGE AND FROM LATER SOUNDS APPARENTLY INSTALLED SAME. *U*

GIANCANA OBSERVED BY BUAGENTS WITH UNIDENTIFIED COUPLE AND FEMALE BELIEVED POSSIBLY IDENTICAL WITH BERGIT CLARK AT CAPE COD ROOM OF DRAKE HOTEL ON EVENING OF FEBRUARY 14 LAST. ACCORDING TO CG 6293-C, GIANCANA PREVIOUSLY OBSERVED ON TWO OCCASIONS DINING AT DRAKE OAK BROOK HOTEL DURING PAST TWO WEEKS. *U*

CG 6293-C ADVISED THAT SECURITY OFFICER AT DRAKE HOTEL HAS CONTACTED ATTORNEY MIKE BRODKIN AND TOLD HIM HE WANTED GIANCANA TOLD TO STAY OUT OF DRAKE HOTELS IN FUTURE. ACCORDING TO INFORMANT, BRODKIN WANTED TO KNOW HOW IT WAS KNOWN THAT GIANCANA AT HOTEL AND WAS TOLD THAT FEDERAL MEN HAVE BEEN MAKING INQUIRY, WHICH NOT FACTUAL BUT FURNISHED TO BRODKIN TO DETER GIANCANA FROM PATRONIZING THESE EXCLUSIVE HOTELS. *U*
