GUS ALEX, AKA, VAR. CG SIX FOUR FOUR THREE C ADVISED THAT GEORGE AND NICK BRAVOS OPERATE BOOKS AT THE RACE TRACKS IN CHICAGO IN VIOLATION

OF TRACK REGULATIONS AND THAT THEY PAY ONE THOUSAND DOLLARS A WEEK TO CAPTAIN FRANK PAPE, CHICAGO PD TO OPERATE THEIR BOOKS AT THE TRACKS. HE STATED THAT PAPE IS ON LEAVE OF ABSENCE FROM THE CHICAGO

PD IN CONNECTION WITH HIS NEW POSITION AS SECURITY DIRECTOR AT ARLINGTON PARK AND WASHINGTON RACE TRACKS. INFORMANT ALSO STATED THAT AN

INVESTIGATION BY THIS OFFICE HAS DISCLOSED THAT QUOTE "BIG TONY" END QUOTE IS TOMMY BOVA. INQUIRY AT RICCARDO/S AND ALSO AT A FORMER RESIDENCE OF BOVA HAS FAILED TO DISCLOSE HIS CURRENT ADDRESS OR OCCUPATION SO THAT HE CAN BE INTERVIEWED. CG SIX FOUR FOUR THREE C

ALSO ADVISED THAT ANOTHER PERSON NAMED TONY LNU WHO IS BROTHER IN LAW OF CHUCKY NICOLETTI WORKS FOR THE BRAVOS BROTHERS AT THE TRACKS AND OBTAINS TWO HUNDRED FIFTY DOLLARS A WEEK FROM THE BRAVOS BROTHERS
