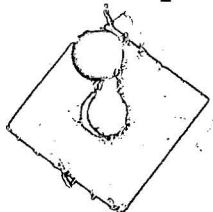

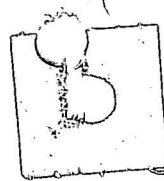

Re Bureau airtel to Baltimore and other offices dated 8/16/63.

A survey of microphone installations deemed ^(being) operated by the Chicago Office has been conducted in accordance with instructions in referenced airtel. Microphones operated by the Chicago Office currently feed into the Chicago Division Central Office plant. The microphone lines are furnished by the Illinois Bell Telephone Company, Chicago, Illinois, and they are obtained through the office contact with the firm's Security Department and are fully concealed in a manner so that the FBI is not identified with the lines. Full security concerning the installing and operation of these microphones is being maintained.
