The above group of buildings is known as Coronet Village, reportedly owned by PAUL J. UNDERWOOD, Owner, held in trust. CG 6491-C advised beneficiaries of several trusts concerning this property are Faries Homes, Inc., and P & H Builders, Inc., which are owned and controlled by PAUL J. UNDERWOOD and his nephew, NEAL FARIES Leoronet Village was constructed by Ed-Son Builders owned by WILLIAM and ALBERT GUESS.

Buildings at 14513 South Kedzie, Chicago, and at 147th and Lincoln Streets, Harvey, Illinois, were bombed 8/5/63 and 7/10/63, respectively, while under construction and unoccupied. Bothebuildings were picketed by Local 134, International Brotherhood of Electricians, AFL-CIO.

It has previously been reported that PAUL J.
UNDERWOOD, who reportedly has a beneficiary in Coronet
Village, has fronted for top hoodlum lieutenants in the
real estate and construction business. Informants have
mentioned lesser hoodlums such as HY LARNER, ROCCO DE STEFANO
and MANNY SKAR, as having an interest in real estate construction
in Southern Cook County. Informants failed to reflect any
information concerning hoodlum interest in Coronet Village.

Arson being investigated by Harvey, Illinds, PD and Fire Department; Chicago PD, Arson Squad; State Fire Marshal's Office, and the Cook County States Attorney's Office.

Any information concerning hoodlum influence in this matter will be brought promptly to the attention of the Bureau. Appropriate military authorities advised.
